WHEREAS, on or about August 11, 2014, ALBERT BALDEO (the "defendant"), was convicted after trial of one count of conspiracy to commit obstruction of justice and six counts of obstruction of justice, as charged in Superseding Indictment S1 13 Cr. 125 (PAC);

WHEREAS, sentencing in this matter was scheduled for January 21, 2015;

WHEREAS, the day when sentencing was supposed to proceed, the defendant reported that he had chest pain and was admitted to Flushing Hospital Medical Center;

WHEREAS, thereafter, the defendant was transferred, at his request, to Long Island Jewish Medical Center;

WHEREAS, on January 26, 2015, the defendant consented, through counsel, for records and test results of his hospitalization to be provided to the Government, and any doctor retained by the Government, so that an independent review and evaluation may be performed;

WHEREAS, the same day, the Court signed an order providing that Flushing Hospital Medical Center, Dr. Nima Taghipour, Long Island Jewish Medical Center, and Dr. Rajiv Jauhar, forthwith provide to the Government, any doctor retained by the Government, and defense counsel for ALBERT J. BALDEO, any and all documents, notes, reports, correspondence, charts, test results, and other records related to the hospitalization, treatment, and evaluation of

ALBERT J. BALDEO;

WHEREAS, the same day, following the signing of that order, the defendant was

transferred to Zucker Hillside Hospital, a part of the North Shore-LIJ Health System, and

remains at Zucker Hillside Hospital;

IT IS HEREBY ORDERED that, at the request of Government, by its attorney Preet

Bharara, United States Attorney, Assistant United Attorneys Daniel C. Richenthal and Martin S.

Bell, of counsel, and for good cause shown, that:

1. North Shore-LIJ Health System, Zucker Hillside Hospital, and Dr. Chris

Burke shall forthwith provide to the Government, any doctor retained by the Government, and

defense counsel for ALBERT J. BALDEO, any and all documents, notes, reports,

correspondence, charts, test results, and other records related to the transfer to Zucker Hillside

Hospital, hospitalization, treatment, and evaluation of ALBERT J. BALDEO; and

2. North Shore-LIJ Health System, Zucker Hillside Hospital, and Dr. Chris

Burke shall continue to provide to the Government, any doctor retained by the Government, and

defense counsel for ALBERT J. BALDEO, any and all documents, notes, reports,

correspondence, charts, test results, and other records related to the transfer to Zucker Hillside

Hospital, hospitalization, treatment, and evaluation of ALBERT J. BALDEO, for as long as he

remains hospitalized.
